



2025/26 School Year Re-enrollment Timeline for Parents – GISW re-enrolls!

January 2025

- **January 3- February 15, 2025: Tuition Assistance Program (Financial Aid) Application Period**
Submit your application for financial aid during this time frame. Contact Ms. April Floyd at afloyd@giswashington.org for any questions.
 - **January 24, 2025: End of First Semester (1. Report Cards)**

February - March 2025

- **February 11, 2025: Budget Membership Meeting**
Join the meeting to participate in the budgeting process and tuition discussions for the next school year.
 - **Mid-February through March 31, 2025: Re-enrollment Period**
Contracts for the 2025/26 school year will be sent out for electronic signature.
 - **Early Enrollment Bonus:** Contracts received by **March 31, 2025** will be eligible for a **\$1000 early enrollment bonus**.
 - **March 31, 2025 Deadline:** After this date, the early enrollment bonus will no longer be available, **and a spot for your child may not be guaranteed for the 2025/26 school year.** Contact Ms. Jeannette Dubrey for any reenrollment and contract questions at admissions@giswashington.org
 - **March 25, 2025: Financial Aid Decision Notification**
GISW will email your financial aid decision. If you believe there was an error, you may request a second review.

April 2025

- **April 9, 2025: Second Parent-Teacher Conference**
The second parent-teacher conference for the 2024/25 school year.
- **April 11, 2025: Re-enrollment Contracts Become Legally Binding**
All re-enrollment contracts signed by this date are legally binding for the 2025/26 school year.

- **April 11, 2025: Financial Aid Decision Review Deadline**
After receiving your financial aid decision, you may withdraw your student's enrollment if you wish, but you must do so by **April 11, 2025** to be released from tuition obligations.

June & July 2025

- **June 26, 2025: Last Day of School**
 - **July 2025: Final Bills Sent**
Final bills for tuition and other fees will be sent out in **July 2025**. Please contact the accounting department with any questions.
-

August 2025

- **August 5, 2025: First Tuition Payment due (Annual Payment Option)**
If you have selected the **Annual Payment Plan**, the full payment is due by this date.
- **August 20, 2025: Semi-Annual Tuition Payment due**
If you selected the **Semi-Annual Payment Plan**, your first payment is due by this date. There is a **\$50 annual surcharge** per student for this option.
- **August 5 or 20: Monthly Tuition Payment is due.** If you selected the **Monthly Payment Plan**, your first payment is due August 5th or 20th. A **\$250 annual surcharge** per family applies for this option.
- **August 21, 2025: First Day of School**

Three Tuition Payment Plans Overview

1. **Annual Payment:** If you signed up for **annual** payment, then full tuition is due on August 5, 2025.
2. **Semi-annual Payments:** If you signed up for **semi-annual** payments, then the first payment is due on August 20th, 2025 (or upon enrollment) and **January 20, 2026**. There is a **\$50 annual surcharge** per student for this option.
3. **Monthly Payments:** If you signed up for **monthly** payments, then your monthly payments begin on August 5 or 20th. A **\$250 annual surcharge** per family applies for this option.
